Dr. Silvia Richter studied medieval and modern history, philosophy and Jewish studies at the University of Heidelberg and the Hochschule für Jüdische Studien Heidelberg, where she submitted her Ph.D. thesis in 2011 on the topic „Language, Philosophy and Judaism in the Work of Emmanuel Levinas and Franz Rosenzweig“. Her research interests include Jewish philosophy (from Moses Mendelssohn to Martin Buber, Franz Rosenzweig, Emmanuel Levinas, etc.), the history of Jewish-Christian relations, autobiographical testimonies of the Second World War and interreligious dialogue. Since 2022 she is working as a project coordinator of the research association “**Dynamics of the Religious (Dynamiken des Religiösen)**” at Goethe university Frankfurt (<https://dynamiken-des-religioesen.uni-frankfurt.de/>), in the team of Christian Wiese.
